Another option is to write and file an answer. Write your response to each of the numbered paragraphs in the complaint in similarly numbered paragraphs. For each paragraph, you can write "admitted" if you agree with what the plaintiff says, "denied" if you disagree, or "lack knowledge" or "unsure" if you're uncertain.

Read the summons and complaint carefully. The summons and complaint (this may also be titled a petition, especially in state court) will tell you how much time you have to file a response. A defendant must respond to the plaintiff's complaint in a short period of time, usually 30 days or less.

Examples: "District Court, State of Washington, Pierce County;" "In the Superior Court of the State of Washington in and for the County of Pierce." The left side lists Plaintiff and Defendant's names. It might list your name and then say JANE DOE or JOHN DOE.
